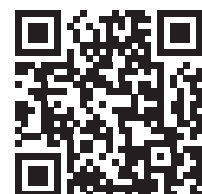

- * **The event is held on Greenbriar Lane between North Baltimore Street & Harrisburg Pike.**
Vendors MUST enter Greenbriar from Baltimore Street/Rte. 74 S and exit on to Harrisburg Pike.
- * Set up will begin at 6:00 am, all vendors are required to be in place and all vehicles removed from the street by 7:45am.
One lane of traffic must remain open at all times during setup. While unloading please keep any vehicles off to the side so that a thorough fare remains open for any emergency vehicles.

- * This is a family event; products of an adult nature are not permitted.
- * The coordinators of this event are not responsible for any accidents, damage or theft.
- * **The event is held on *Greenbriar Lane* between North Baltimore Street & Harrisburg Pike. Vendors MUST enter Greenbriar from Baltimore Street/Rte. 74 S and exit on to Harrisburg Pike.**
- * Set up will begin at 6:00 am, all vendors are required to be in place and all vehicles removed from the street by 7:45am. One lane of traffic must remain open at all times during setup. While unloading please keep any vehicles off to the side so that a thorough fare remains open for any emergency vehicles.
- * Vendors are required to remain in place until 3:00 pm unless otherwise directed by the organizers. NO VEHICLES will be permitted back onto the street until the pedestrians have dispersed and deemed safe by the coordinators. One lane of traffic must remain open at all times during tear down. While loading please keep any vehicles off to the side so that a thorough fare remains open for any emergency vehicles.
- * **You are responsible for cleaning your area. There is to be no dumping of any liquids and do not leave debris behind. Area will be inspected before you leave to assure no grease or other debris has been left.**
- * Menu items **must be approved** by the coordinators of this event.
